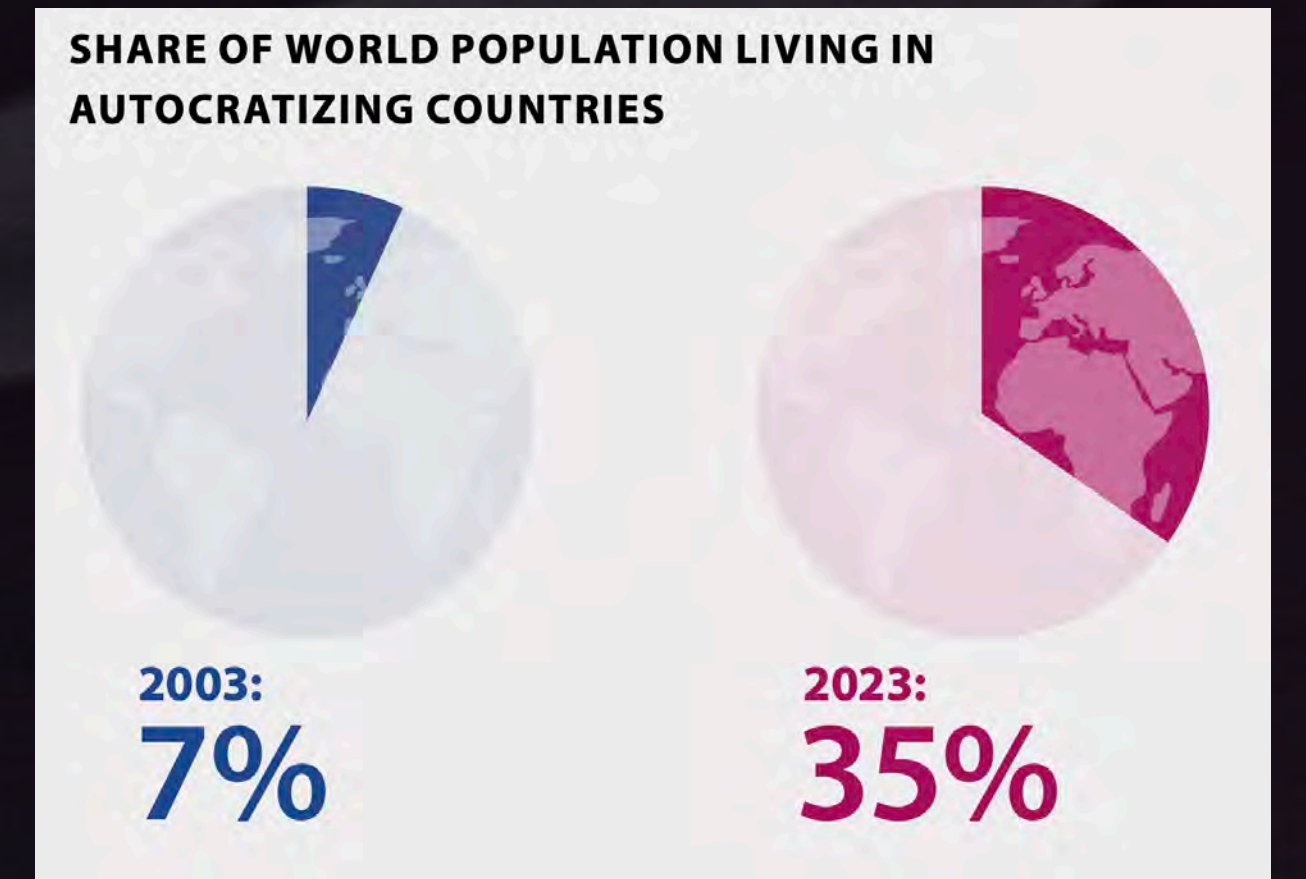
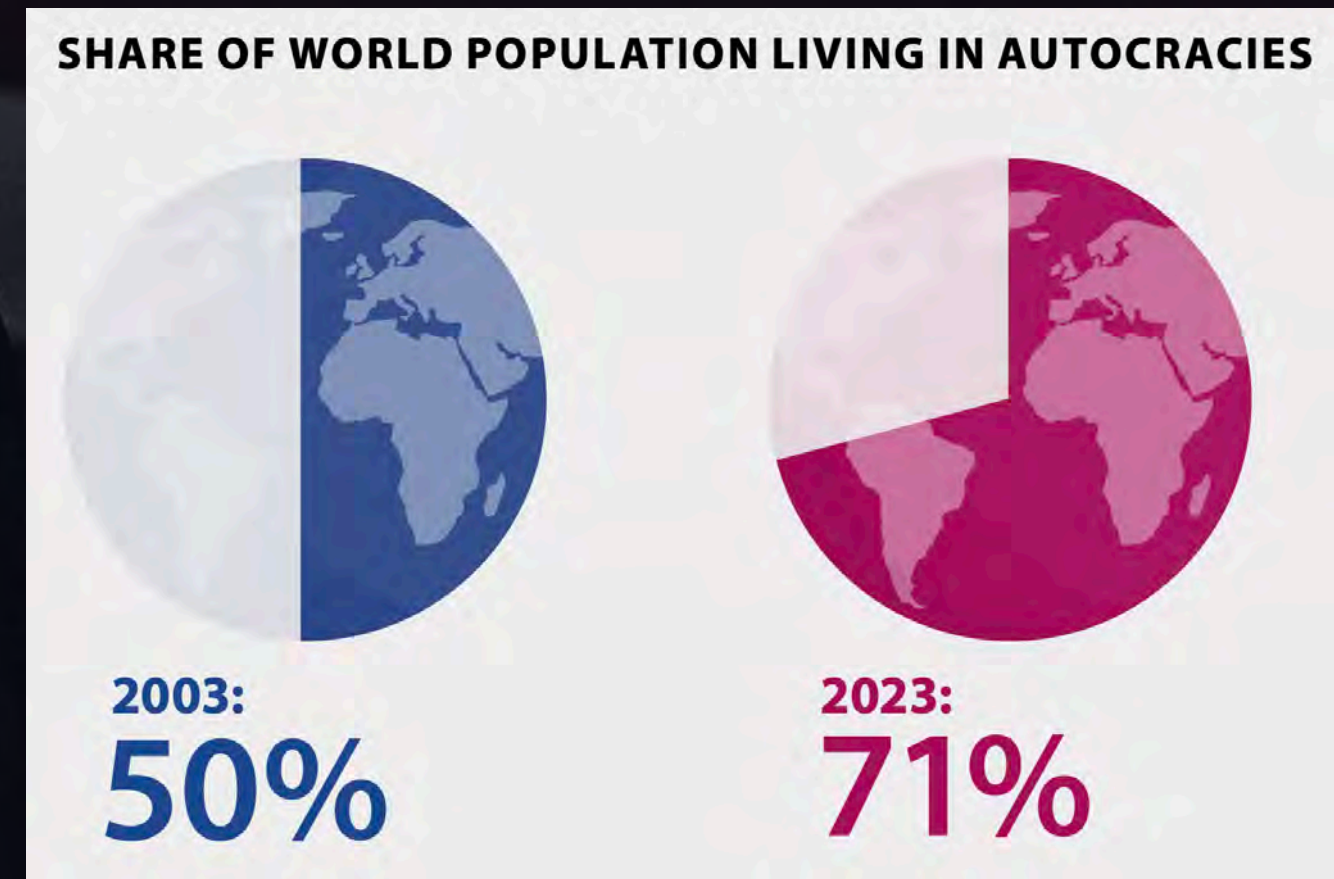
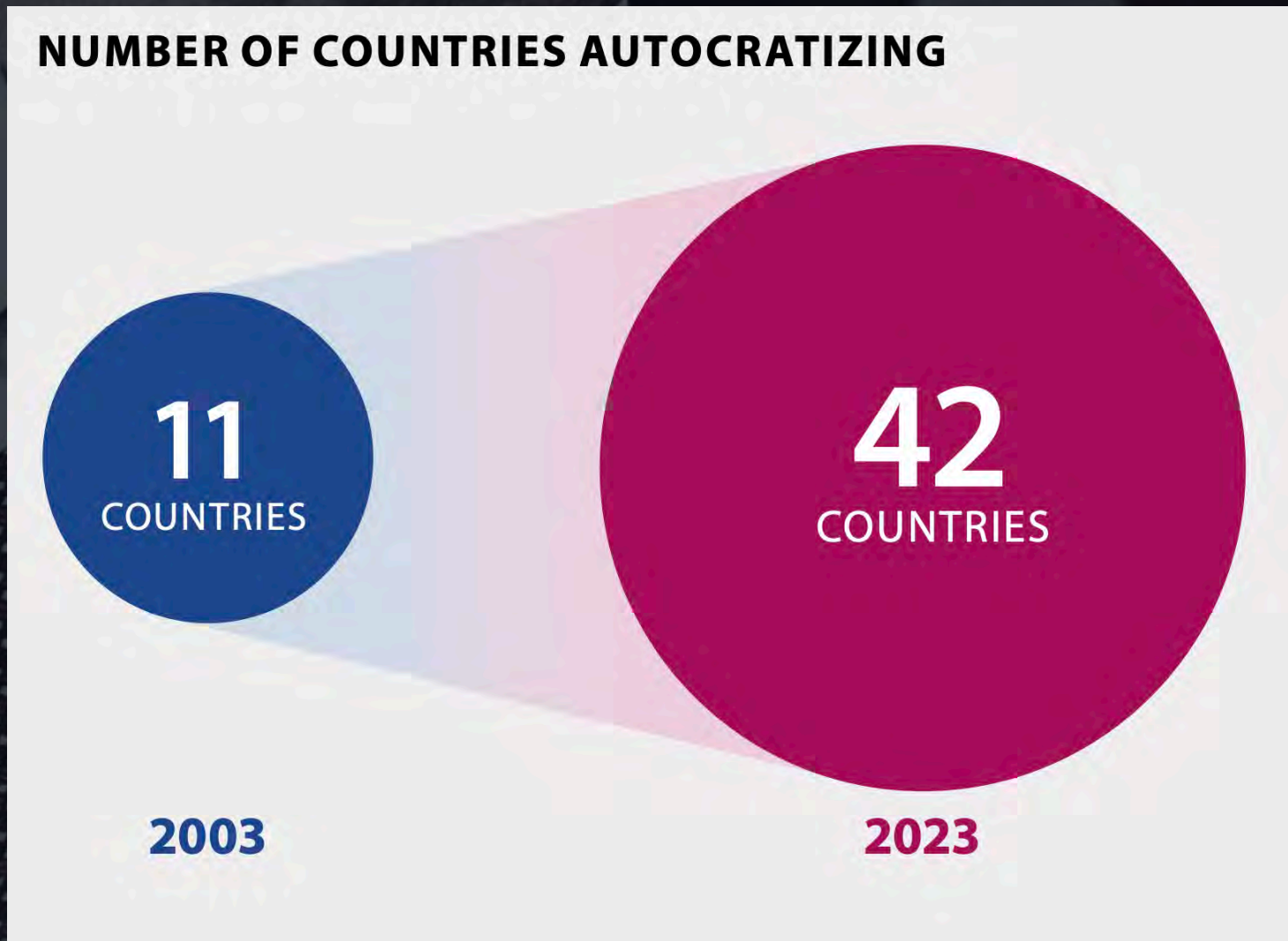
BACKGROUND

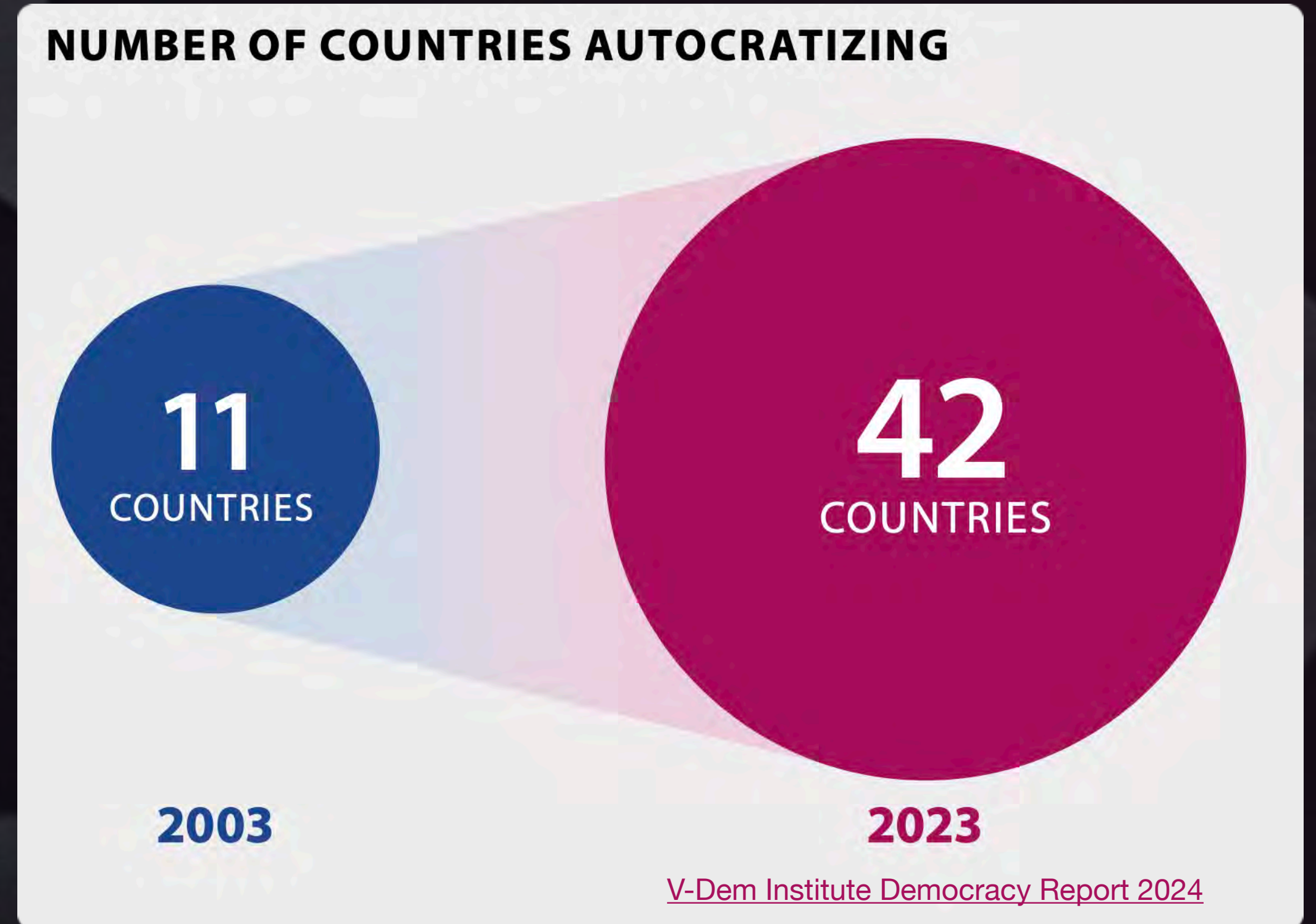

Step 1

a. Make absurd statement of fact

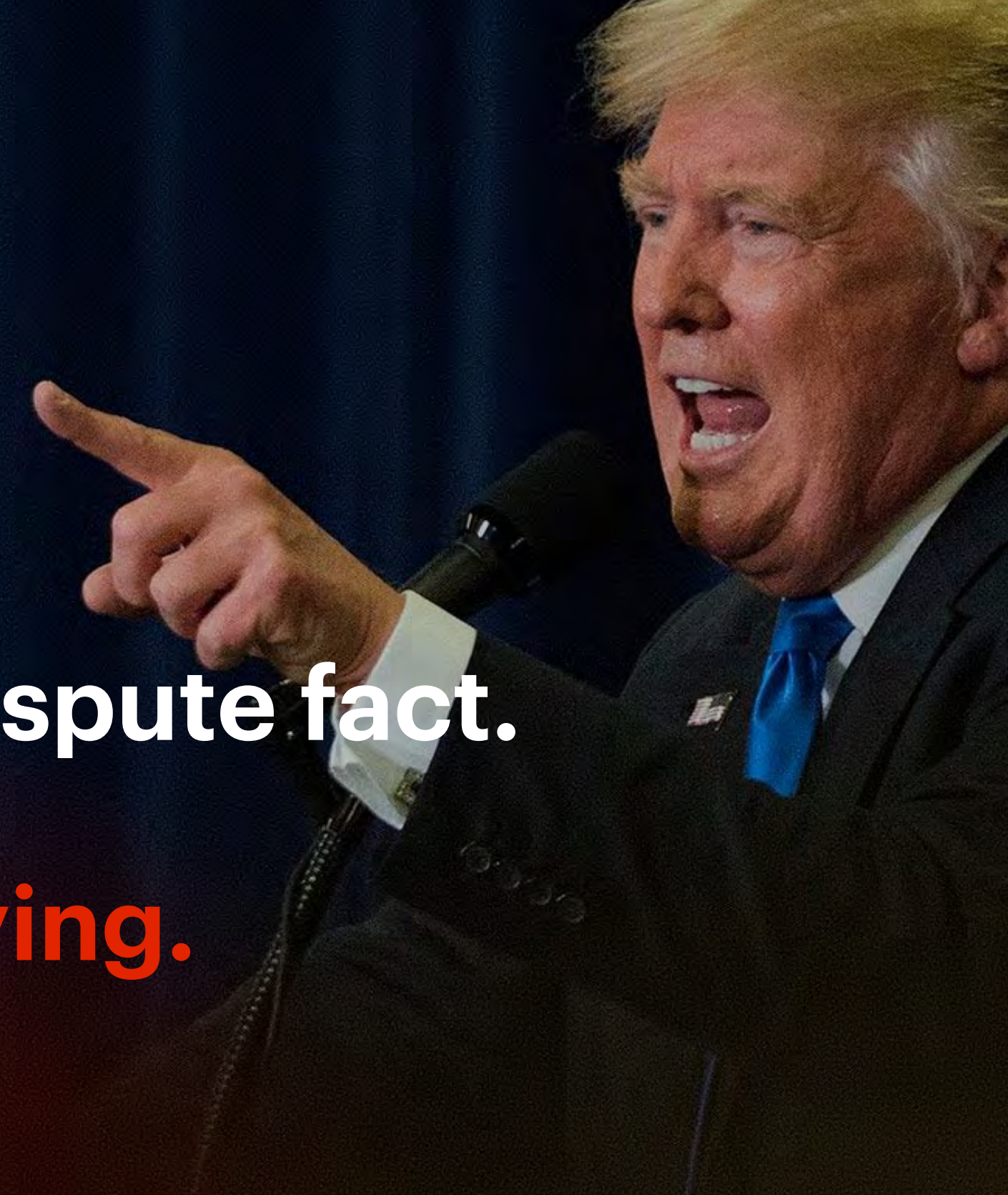
b. Opponents, media, public officials/servants dispute fact.

c. Double down and accuse “establishment” of lying.

d. REPEAT b & c

**Autocrats want to be called liars.
That’s why Autocrats *double down on lies,*
*even when proven untrue.***

**This ensures the question of “who’s the liar” and
disputes over simple facts stay unresolved.**



Step 2

Without agreement on the facts, voters distrust politics and the establishment. They either disengage or have little choice but to vote on personality and promises.

If the autocrat wins the election...

Step 3

...They can now claim a mandate to replace the judges, journalists and public servants they accused of dishonesty.

Fraud Act 2006

2006 CHAPTER 35

An Act to make provision for, and in connection with, criminal law relating to obtaining services dishonestly.

BE IT ENACTED by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

Fraud

1 Fraud

(1) A person is guilty of fraud if he is in breach of subsection (2) (which provide for different ways of committing fraud).

(2) The sections are—
(a) section 2 (fraud by false representation),
(b) section 3 (fraud by failing to disclose information),
(c) section 4 (fraud by abuse of position).

(3) A person who is guilty of fraud is liable—
(a) on summary conviction, to imprisonment for a term not exceeding 12 months or a fine (or both);
(b) on conviction on indictment, to imprisonment for a term not exceeding 10 years or a fine (or both).

(4) Subsection (3)(a) applies in relation to a person who is guilty of fraud in relation to a contract as if there were a reference to 6 months.



Misrepresentation Act 1967

1967 CHAPTER 7

Damages for misrepresentation.

(1) Where a person has entered into a contract after a misrepresentation has been made to him by another party thereto and as a result thereof he has suffered damage, if the person making the misrepresentation would be liable to damages in respect thereof had the misrepresentation been made fraudulently, that person shall be liable notwithstanding that the misrepresentation was not made fraudulently if he proves that he had reasonable ground to believe and did believe up to the time the contract was made that the facts represented were true.

(2) Where a person has entered into a contract after a misrepresentation has been made to him otherwise than fraudulently, and he would be entitled, by reason of the misrepresentation, to rescind the contract, then, if it is claimed, in any proceedings in respect of the contract, that the contract ought to be or has been rescinded, the court or arbitrator may declare the contract subsisting and award damages in lieu of rescission, if of opinion that it would be equitable to do so, having regard to the nature of the misrepresentation and the loss that would be caused by it if the contract were not rescinded, as to the loss that person claiming damages has suffered or is likely to suffer.



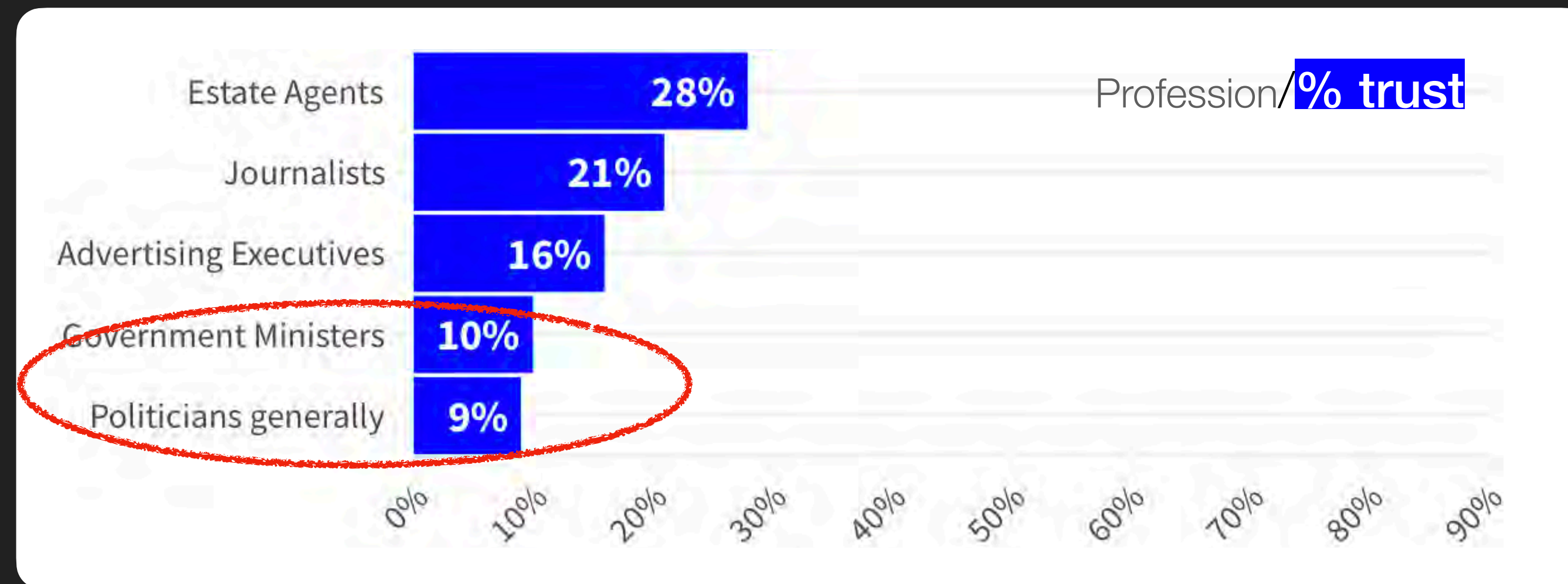

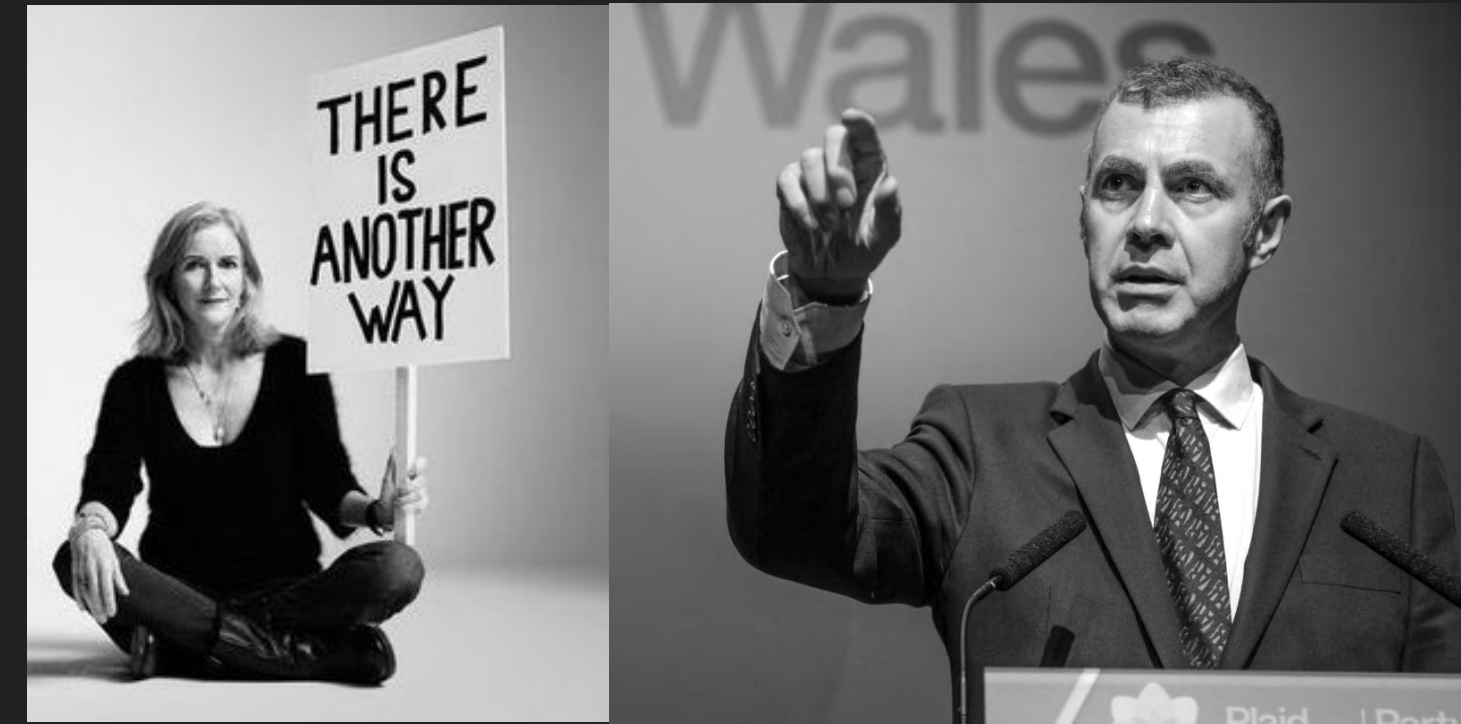

Members of the Senedd described it as a historic moment that would combat the “existential threat” that lying in politics poses to democracy.

The Labour-led Welsh government has committed to introduce “globally pioneering” legislation that would in effect make lying in politics there illegal.

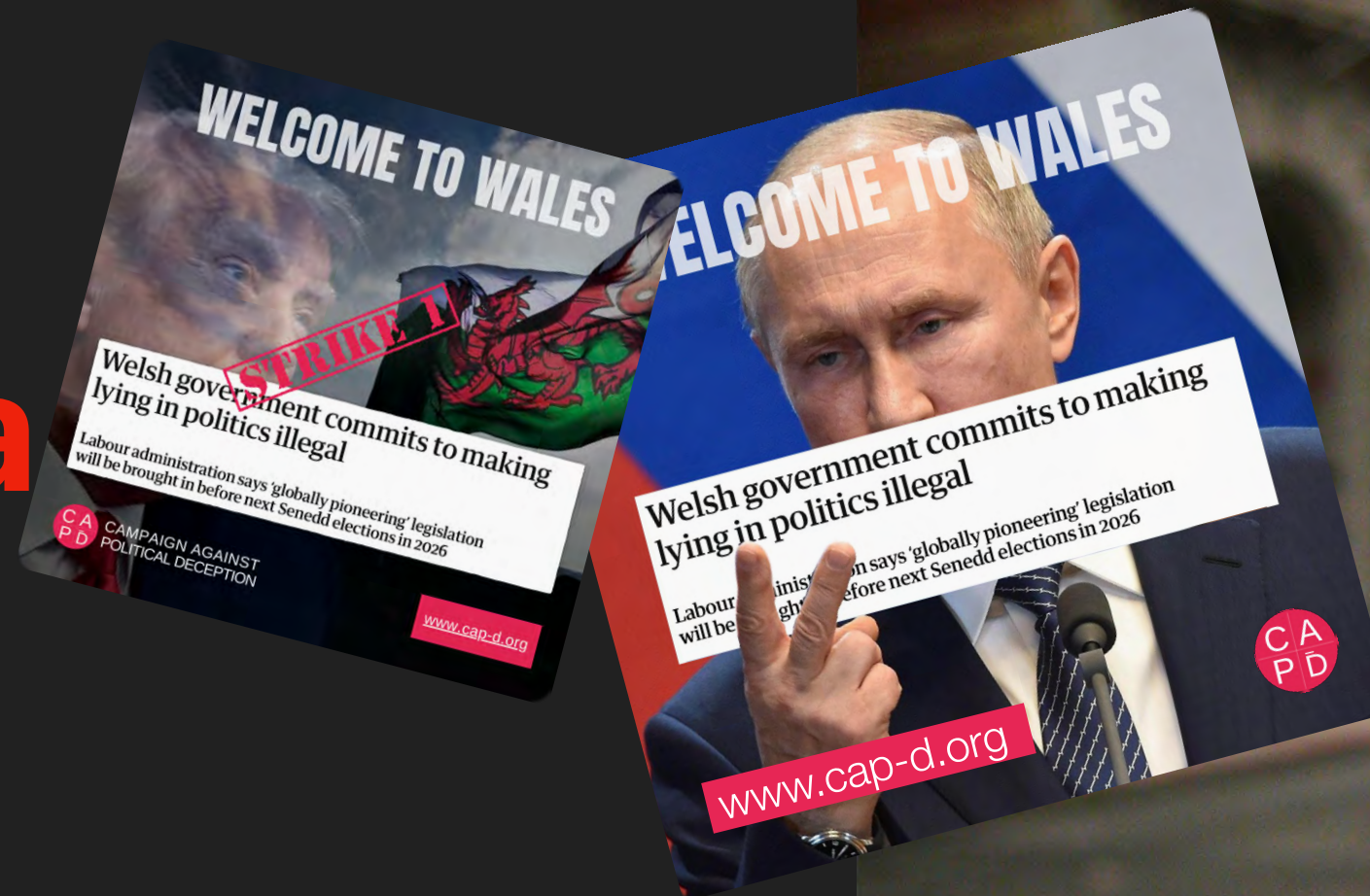

Born into a Welsh mining family Adam has served as a Member of Parliament, Member of the Senedd and party leader (Plaid Cymru - the first out gay man to lead a UK political party). As a Fulbright scholar he studied at Harvard - becoming a fellow of the Centre for International Development at the John F. Kennedy School of Government.

An accomplished speaker and communicator, Adam contributes regular to The Guardian, The Sunday Times, Channel Four and Hay Literature Festival on a wide variety of issues. As a campaigner Adam first pursued honesty and transparency in politics as an MP when he uncovered the Mittal Affair in 2002 where the Steel magnate Lakshmi Mittal, a major Labour Party donor, lobbied Tony Blair to help purchase Romania's steel industry.

Sam Fowles is a barrister, author, and columnist. He serves as Director of the Institute for Constitutional and Democratic Research and Counsel to the APPG on Democracy and the constitution. Sam's book, "Overruled: Confronting Our Vanishing Democracy in 8 Cases" ("unflinching and brilliant" - TLS) was a Times "best of" 2022 and an Amazon bestseller.

Sam is a contributor to the Guardian and a columnist for City AM and Perspective Magazine. He regularly appears in national and international broadcast media, including Sky News, Good Morning Britain, Radio 4, BBC Business, and Times Radio.
